HOW TO PACK A MyGIG NAV. UNIT:

European postal standards stipulates that a package, regardless of marking's and warning texts. Sent within the European postal system. Shall resist a drop from no less than 2 meters.

It is therefore of greatest importance that you pack your MyGIG very, very well. Here are some guidelines that you need to observe.

*** Use chock absorbing material!!

*** Wrap in plastic bag to protect from water!



The cardboard box must be strong and shield the content. No shoe-box, please!!



We recommend that there shall be at least 5-10 cm space on each side to absorb the chock if dropped.



MARKINGS:

Make sure to mark the parcel both with name, address as well as email. We use email as our primary customer ID.



MARKING's ON THE NAV. UNIT's:

Put the same markings on the navigation units as on the parcel. If many nav's. Mark each nav. with preferred service ("RER to REW", "RER to REP, REN to REZ" etc. etc.).



INSTRUCTIONS FOR CUSTOMERS IN NONE EU-COUNTRIES

Meanwhile sending goods between EU countries is painless. Import and export outside EU requires certain steps to be taken by the customer.

Customtronix do not pay any import duties and VAT for its none EU customers. Any parcel coming to us with a VAT claim or any other import duties are turned away. WE DO NOT ACCEPT SUCH SHIPPINGS. The parcel will be shipped back to country of origin on the customer's expenses.

We therefore recommend that customers in (such countries like Schweiz). Either makes the short trip to a close-by EU country and post the parcel from that country. Or use a tax-refund service that FedEx, DHL, UPS and others couriers services offers.

If you ship with a courier service (like FedEx) make sure to mark the "All duties and Tax are paid by the sender" box.
